## PART 1: AUTHORITY AND PURPOSE

- 1.1 These regulations have been adopted by the Chuuk Public Utility Corporation (CPUC) pursuant to CSL Law No.3-97-05 of the State of Chuuk.
- 1.2 These regulations and technical provisions and specifications which may be adopted by CPUC from time to time, shall have the force and effect of law and shall be binding on all persons and entities subject to the jurisdiction of the State of Chuuk.
- 1.3 The purpose of these regulations is to establish requirements for connection to CPUC Water Supply System where and when CPUC Water Systems are available and to establish fees for the use of and connection to CPUC Water System.
- 1.4 These regulations are only applicable where CPUC Water Systems exist in the State of Chuuk.

## PART 2: DEFINITIONS

- 2.1 For the purpose of these Regulations, unless it is evident from the context that a different meaning is intended, certain words and phrases used herein are defined as follows:
  - 2.1.2 **Appurtenance** shall mean valves, stops, bends, elbows, reducers, bushings, plugs, caps, blocks, jackets, manholes, and all other objects, fittings, or installations required to make a complete installation.
  - 2.1.3 **Authorised Officer** shall mean the person responsible for CPUC water supply operations reporting to the CEO of CPUC
  - 2.1.4 **Cost of Service Connection** shall mean the sum of the cost of the labor, materials, transportation, equipment, excavation and road repair, if any, and other incidental charges necessary for the complete installation of a water service connection, but excluding the cost of the meter and meter box.

- 2.1.6 **Customer** shall mean the person, firm, partnership, corporation or association, regardless of government-connected status, governmental department, or other legal entity whose name appears on the record of CPUC as the party responsible and liable for receiving water service.
- 2.1.7 **Customer's Pipe** wewen pwe ewe paip a kawor seni ewe nepwopwun nenien kapachetaa usun a affat me non 2.1.18 ngeni ewe nenien ewe chon eaea konik.
- 2.1.7 **Customer's Pipe** shall mean the pipe extending from the Service Connection as defined in 2.1.18 to the customer property.
- 2.1.8 **CPUC** wewen ewe Chuuk Public Utility Corporation non Chuuk State.
- 2.1.8 **CPUC** shall mean the Chuuk Public Utility Corporation of the State of Chuuk,
- 2.1.9 **CPUC Water System** wewen ewe nenien konik mi nomw fan nemenien me amwokut seni CPUC.
- 2.1.9 **CPUC Water System** shall -mean the water system owned and operated by the CPUC
- 2.1.10 **Chief Executive Officer** wewen ewe aramas a eani ewe angang Chief Executive Officer non CPUC.
- 2.1.10 **Chief Executive Officer** shall mean the person holding the position of Chief Executive Officer of the CPUC.
- 2.1.11 **Governmental Department** wewen pun ekkewe pwutai ika kinikinin non muun, me/ika nenien offes non Chuuk, pachonong pwan ew offes mi pusin mokutukut won winikapan.
- 2.1.11 **Governmental Department** shall mean any department branch, and/or agency of the Chuuk State Government, including an autonomous agency.
- 2.1.12 **Main** wewen pun ewe auonamen neni ia ekkewe angangen kappachetan paip ra pachetta ngeni.
- 2.1.12 **Main** shall mean CPUC Water System supply pipe to which service connections are made.
- 2.1.13 **Or Approved Equal** wewen pun ewe pisek epwe fis pun siwinin nge epwe pwan pachetaa pun siwinin, ika pun a wor mumuta non fofoun makken taropwe seni ewe a kefinita pun epwe mesemes non ewe fansoun me mwann ar repwe fori ewe angang.
- 2.1.13 **Or Approved Equal** shall mean a substitute brand or article which may be installed in place of the one name, where such substitute has been approved in writing by the Authorised Officer prior to the actual construction of the Project.
- 2.1.14 Fan asengesin ika **awenewenan soueaea seni CPUC me mumutan ewe neni me afeiteaan ngeni CPUC** epwe weweoch pun ewe neni me fefeitaan epwe pusin amokut seni, me pwan mumutaan epwe foor seni CPUC.
- 2.1.14 In the matter of **Ownership by CPUC and Conveyance of Property and Improvements to CPUC** it shall be understood that the property and improvements are owned by, and that conveyance is made to CPUC.
- 2.1.15 **Project** wewen pwe forutaan och angang ika ewe angangen aeochuono epwe fooruno non
- 2.1.15 **Project** shall mean the structure, undertaking, or improvement to be constructed in whole or in

- 2.1.17 **Development Water System** wewen pwe ewe auwonamen nenien konik non chok eew neni, pachonong ewe nepwopwun, nenien suki me esipa, watten paip mi utta, paip epwe pachetaa nepekin, pom, dankk, me meinisin ekkewe pisekin kapachetaan paipen konik fanitan epwe awora konik me eppetin kar faniten fefeitaan ika mi pwan tufich ren ewe nenien konik.

- 2.1.19 **Service Connection** wewen pwe ewe nepwopwun nenien kokus, paipen kapoo, me nenien suki me esipa seni ewe nepwopwun nenien konik pwan pachonong ewe miter me ewe nenien esipa.
- 2.1.20 **Service Limits** wewen pun ewe aukukun tekian ngeni ewe neni ia a wor konik. Ewe nenien konik epwe iei usun tekian ren ipwuku fit me fan tekian ewe nenien kokusuno non ewe nenien isois faniten ewe neni.
- 2.1.21 **Development** wewen ewe fefeitan fonu ika fonu epwe kinikin ika nomw won anapanapen an epwe kinikin non ruu ika chomong kinikinin fonu, neeni ika ekkoch kinikinin fonu pachonong kefinitaan eaeen ewe fonu, faniten ei popun, ika epwe ew
- part through the performance of the work covered by these Regulations and all other, Special Provisions.
- 2.1.16 **Standards** shall mean. CPUC Standards and/or Water System Planning, Materials, and Construction of the Water Division.
- 2.1.17 **Development Water System** shall mean the water system, %vithin only Development, including mains, valves, hydrants, laterals, pumps, tanks, reservoirs, and all appurtenances necessary to provide water and fire protection for such Development, and where necessary, sources of supply.
- 2.1.18 **Developer** shall mean a person, firm, corporation partnership, association, governmental department, trust or other legal entity, or a combination of any thereof who, or which causes land to be divided into two or more lots, parcels, sites, or other divisions of land for the purpose, whether immediate or future, of sale, lease, rental, transfer of title to or interest in, any or all of such parcels, and shall include redevelopment, and when appropriate to the context shall relate to the process of subdividing or the land or territory subdivided.
- 2.1.19 **Service Connection** shall mean the main tap,- pipe fittings, and valves, from the water main to and including the meter and shut-off valve.
- 2.1.20 **Service Limits** shall mean the maximum elevation to which adequate water service is available. The service unit shall be that elevation which is 100 feet below the spillway elevation of the supplying reservoir for the area.
- 2.1.21 **Development** shall mean improved or unimproved land or lands divided or proposed to be divided into two or more lots, parcels, sites, or other divisions of land including designation of easements, for the purpose, whether immediate

2.1.22 **Water Authority** shall mean the CPUC.

2.1.23 **Water Service** shall mean service connection as defined in paragraph 2.1.19. This term also refers to the delivery of water to customer.

2.1.24 **Work** shall be understood to mean all equipment, materials, operations and incidental activities necessary for the completion of any part or all of the Project covered by these Regulations.

- 3.1 Pwan ew nongonongun an ekkewe aramas repwe eaea konik, Epwe wor an CPUC me ewe a kefnita pun epwe mesemes won ewe angang pung me nemenem ar repwe tonong won ewe aan, pungun tonong, me ekkoch nenien muun ika fonuen aramas, faniten popun me auchean angangen me kapachetaan ekkewe pisek, me pwan foorsefan, anganga, aeochuono, etti, siwini, me fori awenewenan sokurion won meinisin kinikinin ekkewe nenien inetin konik.
- 3.2 Ese wor niwin epwe kawor ngeni ika kawor seni ese pwan nifinifin aramas, muun ika ekkewe sopai, faniten awesin angang nepekin me orun ewe nenien inetin konik nupwen ewe angang a fis non nenien ewe chon eaea konik.
- 3.3 Meinisin pisek mi pacheta won fonuen ewe chon eaea konik pachonong, nge ese pwan aukuk ren paipen konik, nenien esipa me suki me miter, usun a kawor seni CPUC faniten kaworen ewe konik epwe pwan chok pisekin CPUC. Epwe wor an CPUC pungun feino ngeni nenien ewe chon eaea konik nge esapw wor kamo, momoo ika amomo non awa faniten ekkoch popun mi awenewen ngeni kaworen ewe konikin eaea, pachonong, nge esapw pwan aukuk ngeni, annean ewe miter, tessin, chekkin, angangen foorutaan, angangen fori pisekin, sokurion, me forsefanin ewe nenien konik. - 4.1 Ekkewe annuk, faniten kaworen aninis ren eaeen konik, usun chok ekkewe annuk a affat ranin an ketiw, iei ra katano.

**PART 3:  
RIGHT OF WAY - RIGHT OF ACCESS**

- 3.1 As a condition for receiving water service by customers, CPUC and its authorized agents shall have the free right and authority to enter upon the roads, rights of way, and other public or private property, for the purpose of constructing and installing therewith, and for repairing, operating, maintaining, removing, replacing, and conducting compliance surveys on all or any portion of its distribution system.
- 3.2 No compensation shall be due to or from any customer, public or private, for clearance work around the water distribution system which is performed on such customer's premises.
- 3.3 All facilities installed on a customer's premises including, but not limited to pipelines, valves and meters, which are furnished by CPUC in order to render water service shall remain the sole property of CPUC. CPUC shall have the right of access to the customer's premises without payment of any charge or rent therefore, at all reasonable hours for any purpose related to the furnishing of water service; including, but not limited to, meter reading, testing, inspection, construction, maintenance, compliance surveying, and repair of facilities. Upon termination of service, and for a reasonable period thereafter, CPUC shall have the right of access to the customer's premises to remove its facilities installed thereon.
- 3.4 The appropriate governmental entities shall provide CPUC with the necessary areas of public property for laying out of the works on public property. Special arrangements, where necessary, shall be made between CPUC and owners of private property for the laying out of the works on private property.

**PART 4:  
EXISTING RULES AND REGULATIONS**

- 4.1 Any regulations, concerning the provision of water services, in existence on the date of adoption of these regulations, are herewith repealed.

**PART 5:  
GENERAL CONDITIONS**

- 5.1 Any prospective customer whose premises are within service limits established by CPUC, is eligible to apply for water services subject to the following general conditions; and subject to the customer's agreement to abide by these Regulations, and other CPUC Rules.
- 5.2 All new water service connections must pass an inspection by CPUC before connection to the utility mains. The first two inspections of the customer's service connection are provided to the customer at no expense. All subsequent inspections shall be charged to the customer based on a standard inspection fee as per the CPUC Schedule of Charges – Annex 1 current version.
- 5.3 Inspections shall be made in the order in which requests for inspections are received.
- 5.4 Discovery of an illegal service connection shall result in an immediate failure to pass an inspection with no further examination of the service connection equipment. Action will be taken in accordance with Parts 10 and 11 of these rules and regulations.
- 5.5 A customer whose service is disconnected for any reason shall have the service connection inspected before it shall be reconnected.
- 5.6 CPUC's responsibility for inspection includes the service connection equipment to the boundary of the customer's property.
- 5.7 The premises must be adjacent to an existing distribution main, and may obtain water service where pressure conditions permits, provided that CPUC has a sufficient water supply developed for that use and for the fire protection to take on new or additional service without detriment to those already served

Customers depending upon a continuous supply of water shall provide emergency water storage and any check valves or other devices necessary for the protection of plumbing fixtures against failure to the pressure or supply of water in CPUC mains. Repairs or improvements will be performed as rapidly as practicable and, in so far as practicable, at such times as will cause the least inconvenience to the customer.

5.14 CPUC will make every effort to maintain proper pressure but will not accept responsibility for unforeseen loss of pressure in its water mains.

5.15 Where property is situated at such an elevation that it cannot be assured of a dependable supply or of adequate pressure from the CPUC distribution system, the customer, in consideration of connection with the CPUC system must agree to accept such water service as is available. When required by CPUC, the customer shall install an air gap check valve, or other protective devices between the customer's supply pipe and the service connection. The customer shall execute a written release in favor of CPUC for all claims on account of any inadequacy in CPUC system or inadequacy of water supply to the customer.

5.16 When the pressure of CPUC supply is higher than that for which individual fixtures are designed, the customer shall protect such fixtures by installing and maintaining pressure reducing and relief valves. CPUC will not be liable for damage due to pressure conditions caused by or arising from the failure or defective condition of such pressure regulators axed relief valves or for damage that may occur through the installation, maintenance, or use of such equipment.

5.17 The resale of water by the customer is not permitted unless approved in writing by the General Manager of CPUC.

**PART 6:  
APPLICATION FOR WATER SERVICE CONNECTION**

- 6.1 Each prospective customer upon requesting water service is required to make an application in order to be considered for service.
- 6.2 The customer shall be responsible for the payment of all charges for water service at the designated location. Charges, including construction and connection costs before service will begin when the water service is established and will continue until due notification from the customer or until disconnection by CPUC for failure of the customer to comply with these Regulations.
- 6.3 When an application for water service is made by a customer who was responsible for and failed to pay all bills previously rendered, regardless of location or time incurred, CPUC will refuse to furnish water service to such applicant until his outstanding CPUC bills are paid.
- 6.4 Persons taking possession of a property and using water services without having made application to CPUC for service/s to such property, shall be held liable for the service delivered. If proper application for water service is not made upon notification to do so by CPUC and if accumulated bills for CPUC services are not paid upon presentation, water and/or sewerage service shall be subject to discontinuance without further notice.
- 6.5 Any non-governmental entity making a new application for service or any existing customers shall be required to make a guarantee deposit to cover charges for utility services.
- 6.6 The amount of the deposit to establish credit required of any customer shall be an amount established by CPUC approximately equal to two months charges for the service or services involved, and as hereinafter indicated.

**PART 7:  
INSTALLATION OF WATER SERVICE CONNECTIONS**

- 7.1 Installation. When the application for water, service has been approved, a service connection will be installed by CPUC at the expense of the applicant. There shall be one meter for each service connection, unless CPUC because of operating necessity, installs two or more meters in parallel. All meters will be sealed by CPUC before installation and no seal shall be altered or broken except by one of it authorized employees.
- 7.2 Installation charge. The cost of the service connection shall be paid by the applicant before the connection is installed. Installation charges shall be based on the cost of such installation as established by CPUC and shall be as initially set at the charges indicated in paragraph 10 which may be revised time to time.
- 7.3 Customer's pipe. The customer shall install and connect at his expense and in accordance wioth applicable standards his supply pipe to the shut-off valve or outlet at the meter installed by CPUC. The customer's pipe shall at all times remain the sole property of the customer, who shall be responsible for its maintenance and repair, If the customer's pipe is installed before the service connection is set, CPUC will make the connection to it provided, however, it is requested, in writing, by the customer prior to the installation of the service connection. Customer supply piping must be copper or schedule 40 PVC or other material specifically approve in writing by the Authorised Officer.
- 7.4 Connection to main. Only employees of CPUC or persons authorized by the Authorised Officer will be allowed to connect or disconnect the service connection to or from CPUC main.
- 7.5 Location of service connection or main. No service connection or water main will be installed by CPUC in any private road, lane, street, alley,

- 7.11 Size of meter and service connection. CPUC will determine the location and size of all meters and service connections to its system.
- 7.12 Open water service supplying multiple structures. CPUC reserves the right to limit the number of houses or buildings and the area of land to be supplied by one service connection.
- 7.13 Water service to undeveloped areas. Any prospective consumer requesting water service for an undeveloped area or tract of land in which a distribution system has not been installed may be required to furnish CPUC with plans and specifications for the proposed distribution system for such area or tract which shall conform to the standards and requirements of CPUC. Such distribution system will be installed at the expense of the custom in accordance with the plans and specifications reviewed and approved by CPUC.
- 7.14 In the case of water main replacement or extensions of new main funded by the CPUC the customer will only be charged for the service line connection and initial deposit as referred to previously.
- 7.15 Damage to CPUC property. Any damage to water mains, service connection, valves, fire hydrants, or other property of CPUC shall be paid for by the person, persons, or legal entity responsible for the damage. Cost of damage will include cost of repairs and the amount of water loss as estimated by CPUC based on accepted engineering.
- 7.16 Service to ships. Water will only be provided to ships berthed at appropriate loading locations e.g. the Weno deep water wharf or Tonoas wharf. Water will be provided only when there is sufficient water in the supplying water system (Weno or Tonoas) to provide water without a detrimental effect on the system. All water provided to ships will be metered. Ships will pay for the cost of water

**PART 8:  
MAIN EXTENSIONS AND EXTENSIONS OF SERVICE**

- 8.1 Extensions of water mains to supply water service to applicants of a permanent character shall be constructed, operated, and maintained by CPUC.
- 8.2 CPUC may impose a moratorium on providing new service to customers or increased service to existing customers, if it is determined that such new service would over-burden the existing network capacity. If a customer violates the conditions of the moratorium by increasing water offtake, the customer may, at the discretion of CPUC, be subject to disconnection.
- 8.3 Any extension of existing water service is contingent upon the availability of funds; which are identified for expansion purposes. CPUC has discretion to determine the area(s) to which water service shall be extended. Water service shall be extended to areas, to which CPUC has determined to extend service, in the order in which applications are approved for service connection.
- 8.4 Any extension of water service to an area other than one to which CPUC has determined to extend service shall be primarily at the customer's expense.
- 8.5 If necessary, and subject to Board approval, the cost of extension of water service may be amortized over a period up to five (5) years, in this case the cost of extension will include financing charges at commercial market rates. In such a case, the customer's water bill shall include both an amount for water consumption at the applicable rate and the amortization payment for the extension of water service.

**PART 9:  
METER READING AND RENDERING OF BILLS**

- 9.1 Water meters will be read and bills rendered monthly or at other intervals as determined by CPUC. Special readings may be made when necessary for closing of accounts or for other reasons.

**PART 10:**

**METER TESTS AND ADJUSTMENT OF BILLS**

- 10.1 Meter tests. All meters shall be tested by CPUC prior to installation. Any customer who, within reason, doubts the accuracy to the meter serving his premises may request a test of the meter. The customer, if he so requests, will be notified as to the time of the test and may witness the test if he so desires. No charge will be made for the first meter test.
- 10.2 Adjustment of bills for meter inaccuracy. If, as the result of the test, the meter is found to register more than two percent fast under conditions of normal operation, CPUC will refund to the customer the overcharge, based on past consumption, for a period not exceeding four months, unless it can be proved that the error was due to some cause, the date of which can be fixed. In this latter case, the overcharge shall be computed back to, but not beyond, such date.
- 10.3 Failure to register. If a meter fails to register due to any cause except the non-use of water, an average bill will be rendered. Such average bill will be subject to equitable adjustment taking into account all factors before, during and after the period of said bill.
- 10.4 Allowances. The customer has the responsibility for the control of the water delivered beyond CPUC service connection and CPUC is not responsible for maintenance and repairs to pipes and fixture beyond the service connection.

**DISCONTINUATION OF WATER SERVICE**

- 11.1 Water and/or sewerage service may be discontinued for reasons as follows:
- 11.1.1 Non-payment of bills      Water,

11.1.2 Non-compliance with CPUC's Regulations. If the customer fails to comply with any of these Regulations CPUC will have the right to discontinue the service.

11.1.3 Customer about to vacate premises. Each customer about to vacate any premises supplied with water and/or sewerage services by CPUC shall give 10 working days notice of his intention to vacate prior thereto specifying the date service is desired to be discontinued. Before buildings are demolished, CPUC should be notified so the service connection can be closed.

11.1.4 Unauthorized use of water. CPUC will refuse or discontinue water service to any premises if necessary, without giving notice, to protect itself against fraud, abuse, or unauthorized use of water.

11.1.5 Wasteful use of water. Where negligent or wasteful use of water exists on any premises, CPUC may discontinue the service if such conditions are not corrected within five days after giving the consumer written notice of its intent to do so.

**PART 12:  
SCHEDULE OF RATES AND CHARGES**

12.1 CPUC may develop and implement rate schedules segregated into customer categories. Implementation of such rate schedules shall be in accordance with Chuuk State Law No. 3-97-05 as amended.

12.2 Current rate schedules are in accordance with Chuuk State Law No. 3-97-05 as amended and approved by the CPUC Board of Directors copy of which is to be posted at all times at CPUC main office and notice boards and included as Annex 1 to these Regulations and updated thereto whenever issued.

12.3 Rate schedules will include information for the following types of charges:

Inspection Fees  
Connection Fees;  
Reconnection Fees;  
Penalties;  
Water Tariff Rates (including standing charges and demand charges where applicable);

Environmental Charges;  
Water Delivery by Truck & Tanker;  
Water Loaded to Ships;

12.4 CPUC's rate schedules shall be interpreted and applied by the CPUC for each customer's service requirement in accordance with the terms and conditions of such rate schedules and the size and characteristic of such service requirements, as these are determined from time to time.

12.5 A customer who is adversely affected by the application of any rate or charge for electric service may challenge the rate or charge, and if the customer and CPUC do not reach agreement, the matter shall be adjudicated in accordance with the State Administrative Procedures Act.

- 12.7.4 An apartment building with one service entrance serving the entire building, that has a commercial business located in the building, is considered commercial for the entire building.
- 12.7.5 Buildings which are used for housing workers (barracks or houses), where the water is purchased and paid for by a commercial business for profit, shall be classified as commercial. Buildings used as offices by private institutions shall be classified as commercial.
- 12.7.6 A residence which includes a commercial business license shall be classified as commercial.
- 12.7.7 A commercial customer is defined as such if a business license is required for the business operation.
- 12.7.8 A government customer is defined as any agency of the FSM national government, the Chuuk State Government or any other entity entitled to government rates by law.

**PART 13:  
CPUC EQUIPMENT ON CUSTOMER'S PREMISES**

- 13.1 All equipment belonging to CPUC and installed upon the customer's premises for measurement, test, check or any other purpose, shall continue to be the property of CPUC, and may be repaired, replaced or removed by CPUC at any time by notifying the customers. The customer shall exercise reasonable care to prevent damage to meters and other equipment of CPUC upon said premises and shall in no way interfere with the operation of same.
- 13.2 Any damage to water mains, service connections, valves, fire hydrants, manholes, or other property of CPUC shall be paid for by the person or organization responsible for the damage.
- 13.3 The customer shall be liable for any damage to a meter or other equipment or property of CPUC caused by the customer or his tenants, agents, employees, contractors, licensees or permittees, on the customer's premises and CPUC shall be promptly reimbursed by the customer for any such damage upon presentation of a bill therefore. In the event settlement for such damage is not promptly made, CPUC reserves the right to discontinue water and sewerage services to such premises.
- 13.4 No obstruction nor guard dogs or any other hindrances shall be placed on or around any water meter, fire hydrant, or valve so as to render it inaccessible.
- 13.5 Any officer or employee of CPUC shall have the right of ingress and egress to the consumer's premises at all reasonable hours for any purpose reasonably connected with the furnishing of water, or other service to said premises and the exercise of any and all rights secured to it by law. In case any such officer or employee is refused admittance to any premises, or being admitted shall be hindered or prevented from making such inspection, CPUC may cause the water services to be disconnected from said premises after giving 24 hours notice to the owner or occupant of said premises of its intention to do so.

**PART 14:  
RESPONSIBILITY FOR CUSTOMER'S EQUIPMENT**

- 14.1 The customer shall at his own risk and expense furnish, install and keep in good and safe condition all equipment that may be required for receiving, controlling, applying and utilizing water; and CPUC will not be responsible for any loss or damage caused by the improper installation of such equipment, or the negligence, want of proper care or wrongful act of the customer or any of his tenants, agents, employees, contractors, licensees or permittees in installing, maintaining, using, operating or interfering with any such equipment
- 14.2 Water service may be discontinued to any customer whose water system includes plumbing fixtures or water containers in any form, or any use, which in the opinion of CPUC may endanger CPUC's water supply from a public health standpoint. Any such discontinuation of service shall continue until objectionable installations have been corrected and CPUC has been assured that the objectionable uses and practices will not be resumed.
- 14.3 CPUC will not be responsible for damage to property caused by spigots, faucets, valves and other equipment that may be open when water is turned on after a temporary shutdown.
- 14.4 Wherever a check valve or pressure reducing valve is installed on the customer's cold water supply line between the main and a hot water storage tank and /or heater, there shall be installed on the customer's hot water distributing system a suitable pressure relief valve.
- 14.5 Where it has been determined that noises emanating from a customer's premises are caused by plumbing fixtures or other equipment attached to water pipes and such noises are being transmitted through the water pipes and causing annoyance to other customers, CPUC may issue a notice in writing to the offending customer or to the owner of such premises or to his agency, giving reasonable time within which to correct or remove the cause of the complaint. Failure on the part of

**PART 15:  
ELECTRICAL GROUNDING**

- 15.1 Protective grounding of alternating current secondary distribution circuits made to the water system shall be subject to written approval by CPUC.
- 15.2 No grounding of direct current system to any portion of the water system shall be permitted.
- 15.3 CPUC will not be responsible for the maintaining of a continuous metallic water piping system and reserves the right, without liability to public utility electric companies, electric customers, or any other agency or individual to create a physical break in its service connections and mains, or to incorporate non-metallic pipes and appurtenances in its system and to make joints of any materials, without regard to their efficiency as conductors of electricity and without giving notice.

**PART 16:  
CUSTOMER'S WATER PUMPING INSTALLATION**

- 16.1 Customers shall not be permitted to install or operate pumps that pump water directly from the mains of CPUC system.
- 16.2 If a customer would like to have a pumping system in his own premises, such pumping should be done from his own storage tanks. Such storage tanks should be constructed after the meter and there should be a 6" air gap between the inlet pipe to the tank and the maximum water level of the tank.
- 16.3 All existing customer pumps after the effective date of these regulations shall cease to operate until approval is given by CPUC. Failure on the part of the customer to comply with this regulation shall be subject to disconnection. of water services until requirements have been made.
- 16.4 A written approval from the Authorised Officer

**PART 17:**

**CROSS-CONNECTION AND BACKFLOW PREVENTION**

17.1 In order to provide proper sanitary protection to CPUC's water supply and to comply with the applicable regulation, CPUC will require that following the effective date of these Regulations no cross-connections with other water supplies, or other physical connections, shall exist, or be installed, located, maintained or operated which could permit backflow of contaminated water or any other dangerous, impure, unsanitary, or unpotable substance from the customer's premises into CPUC water supply system, except as provided below:

17.1.1 Cross -connections with other water supplies. Owners (or Operators) of presently existing water supplies which are in active use and cross-connected to CPUC's system will be required to install check valves, air gaps or other devices to minimize the hazards of such cross-connections. Permits will be granted on a provisional basis, renewable yearly, under the following conditions:

17.1.2 Where such water supplies are regularly examined by CPUC and EPA and are approved by CPUC and EPA as acceptable, safe Laid sanitary supplies and continue as such at all times While the connections are in existence.

17.1.3 Where such water supplies do not meet the requirements of (paragraph 1) above, are not normally under pressure and are maintained solely for fire-fighting purposes, and where adequate protection against back-flow to CPUC water system is provided by mechanical, or other methods or devices satisfactory to CPUC.

Plans and specifications for such installations must be approved by CPUC.

All such devices shall be tested and inspected internally not less than once annually or more often in those instances where successive inspections indicate repeated failure. Repairs, replacement of parts, etc., shall be made whenever necessary at the expense of the customer. Making tests and annual inspections shall be the responsibility of the customer and shall be furnished to CPUC. Failure of the customer to make the proper tests and submission of records may result in CPUC's making the tests, needed repairs and replacements and charging the costs thereof to the customer.

### **USE OF AND DAMAGE TO FIRE HYDRANTS CHANGE IN HYDRANT LOCATION**

- 18.1 The primary purpose of the provision of fire hydrants in CPUC water systems is to assist the Department of Public Safety to carry out their responsibility of protecting the public from fire hazards. CPUC and Division of Public Safety will enter into a Memorandum of Understanding delineating each others obligations. CPUC will provide specified services for agreed upon costs borne by the Division of Public Safety.
- 18.2 Use of Fire Hydrant. Any use of a fire hydrant or tampering therewith or the taking of water there from for purposes other than fire protection by persons other than authorized employees of the Division of Public Safety or of the CPUC is prohibited, except upon prior application to and written permit by CPUC. The Division of Public Safety shall have the prior right to use any hydrant at any time and shall have the authority to remove temporarily, if necessary in case of fire, any connection that may be made to a hydrant under a permit issued by CPUC. The use of any hydrant under a permit and the connections thereto shall be subject to the direction and approval of the CPUC, including the payment of appropriate charges.
- 18.3 Application for Permit. Application for a permit for the use of a fire hydrant for purposes other than fire protection shall be made in writing to CPUC and when required, shall be accompanied by payment of the applicable connection charges. It shall be non-transferable and shall be shown by the permit, its agents or employees upon demand. CPUC reserves the right to reject any application, to refuse to issue any permit and to revoke any permit at any time. No permit will be issued unless the permittee agrees to notify CPUC as soon as the use of the hydrant is finished. In the event that a permit shall be revoked., the use of the hydrant thereunder shall cease immediately and all connections thereto shall be properly removed forthwith. CPUC will inspect each hydrant which

All water drawn from a hydrant under permit shall be metered or estimated by CPUC and shall be paid for by the permittee at the current water rates. A traveling portable meter will be issued the permittee by CPUC for this purpose. The permittee shall make the meter available to CPUC for reading upon request. Any damage caused to the meter during the time of use by the permittee shall be paid for by the permittee. The permittee shall pay all of the costs of connecting to and disconnecting from the hydrant.

18.4 Hydrant Wrenches. Only fire hydrant wrenches which shall have been approved by CPUC shall be used for the operation of fire hydrants.

18.5 Damage to hydrant or property. The permittee shall report promptly any defect in or damage to the hydrant. The cost of any damage to property including the hydrant or of any injury to persons resulting from the use of the hydrant shall be paid for by the permittee. CPUC will not be held responsible for any damage to property or injury to persons arising from the use of any hydrant for any cause whatsoever. Any damage to fire hydrants shall be paid for by the person or organization responsible for the damage.

18.6 Change in hydrant location. CPUC will, in consultative with the Division of Public Safety, change such location of a fire hydraulic provided the cost of all labor, material, equipment and all other charges are paid by the person requesting such change.

**PART 19:  
WATER SYSTEM DEVELOPMENT REGULATIONS**

**19.1 Availability of Water and Approval of Development Map**

19.1.1 Extensions from and connections to the public water system will be approved by CPUC where pressure conditions permit; provided that CPUC has a sufficient water supply developed for domestic use and for fire protection to take on a new or additional service without detriment to those already served and the development water system otherwise conforms to these Regulations,

19.1.2 In areas where there is no CPUC water supply system is available, or where large quantities of water are required; or a large investment is necessary to provide service, the developer will be informed as to the conditions under which the development may be approved.

19.1.3 After a governmental department submits the development map to CPUC along with the backup information, CPUC will inform the department in writing of its approval, requirements for approval, or its disapproval of extension or connection to CPUC water and/or sewerage system map based on water utility service capabilities. No statement, prior to CPUC approval, should be construed as guaranteed availability of water service at a certain location where development is proposed to take place. CPUC approval will only be given if all Government Planning Rules and Regulations, including Environmental Impact Assessment if applicable, outside those of CPUC itself have been complied with and evidence thereof furnished by the relevant department.

**19.2 Extension to Development**

19.2.1 General Requirement. The developer shall install and pay for the development water main extension required from CPUC water and systems to the development. All such extensions shall be designated and located in

19.2.2 increase in Size of Water Main Extensions for Service to other Areas. Whenever CPUC finds it is necessary that the water mains need be of a greater capacity than to provide adequate service and fire protection for such development, in order to supply water and fire protection to property not in the development, it shall require the developer to install mains of such greater capacity.

19.3 Installations Within Development

19.3.1 General Requirement. The developer shall install in accordance with these Regulations and the Standards of CPUC and pay for the development water system required within a development.

19.3.2 Increase in size of water and/or sewer mains within development for benefit of other areas. Whenever, in order to provide for existing or future services beyond the boundaries of a development, CPUC finds that mains to be installed within the development should be of greater capacity than would be required to provide adequate service within such development, CPUC will require the developer to make installations of such greater capacity.

19.3.3 If and when reimbursement to developer ,who is required to install a larger size main for the reason set forth in the proceeding paragraph, CPUC will reimburse the developer, as soon as practicable after acceptance by CPUC of the completed work, the additional cost of the installation over and above the cost of the mains that would have been required; provided, however, that in no case will reimbursement be made of any portion of the cost of an 8-inch main in other areas; provided further that reimbursement will not be made to the developer where such larger main or mains will serve only areas under the same ownership as the development under consideration.

19.3.4 After the installation has been completed and

**19.4 Mains, Hydrants in Developments**

19.4.1 Locations and sizes of mains, fire hydrant locations and other pertinent design criteria shall be determined by CPUC Authorised Officer.

19.4.2 Fire Protection. In fixing the standards for fire protection insofar as water supply is concerned, CPUC will be guided by the standards of the National Board of Fire Underwriters.

**19.5 Preparation and Approval of Plans, Elevation Agreement, Delay in Construction**

19.5.1 Preparation of Plans. All construction plans shall be prepared by a registered engineer to the extent of his professional qualifications and approved by CPUC Authorised Officer. Tentative maps and final maps of developments to be reviewed by the CPUC shall fully conform to the definitions and requirements of the development Rules and Regulations of the Chuuk State Government.

19.5.2 Elevation Agreement. Whenever a lot or lots within a development are at such an elevation that they cannot be assured of a dependable water supply, the approval of the construction drawings will be subject to each owner of such lot or lots signing an "Elevation Agreement". Whereby such lot owner agrees to accept such water service as CPUC is able to render, and such owner agrees to construct, if necessary, and maintain at his expense a water tank or a pump with a water tank, all in accordance with the Standards and Requirements of CPUC, of sufficient capacity to furnish a supply of water at such times as the pressure in the water mains may be insufficient to supply such lot or dots with water. When required, a statement as to this conditional approval will be clearly lettered on the construction drawings by CPUC.

- 19.5.3 Approval of Plans, No construction of a development water system, or any portions thereof shall be undertaken prior to approval of the final construction plans by CPUC. After said approval, the developer shall transmit four sets of all final construction plans to CPUC. In areas where there is no CPUC water supply available to serve the development, plans specifications for the development of water sources, including wells tunnels, shafts, pumps, buildings, mains and other appurtenant structures and devices, shall be approved by CPUC in their entirety prior to construction.
- 19.6 Materials and Construction Standards, Installation of Water Service
- 19.6.1 Materials and Construction Standards. All materials, design and construction procedures, and workmanship, with respect to any development water system, or any portion thereof shall be in accordance with the requirements and Standards of CPUC,'
- 19.6.2 Installation of Water Service. No water service will be approved, excepting a service for development construction purposes, until the development water system has been completed and accepted by CPUC and all the improvements required by the Development Rules and Regulations have been completed,
- 19.7 Ownership of Installed Water System
- 19.7.1 As a condition precedent to connecting the project water system to the public water system, the developer shall convey the water system to CPUC and said system thereafter will be maintained and operated as a part of the public water system provided, however, that CPUC may refuse to operate and maintain facilities installed without CPUC's prior approval. Prior to commencement of water services and as a prerequisite to such service, the developer shall deliver to CPUC perpetual easements for all portions of the water system installed other than publicly owned property.
