**PART 1:  
AUTHORITY AND PURPOSE**

- 1.1 These regulations have been adopted by the Chuuk Public Utility Corporation(CPUC) pursuant to CSL Law No.3-97-05 of the State of Chuuk.
- 1.2 These regulations and technical provisions and specifications which may be adopted by CPUC from time to time, shall have the force and effect of law and shall be binding on all persons and entities subject to the jurisdiction of the State of Chuuk.
- 1.3 The purpose of these regulations is to establish requirements for connection to CPUC Sewerage System where and when CPUC Sewerage Systems are available and to establish fees for the use of and connection to CPUC Sewerage System.
- 1.4 These regulations are only applicable where CPUC Sewerage Systems exist in the State of Chuuk.

**PART 2:  
DEFINITIONS**

- 2.1 For the purpose of these Regulations, unless it is evident from the context that a different meaning is intended, certain words and phrases used herein are defined as follows:
  - 2.1.1 **Appurtenance** shall mean valves, stops, bends, elbows, reducers, bushings, plugs, caps, blocks, jackets, manholes, and all other objects, fittings, or installations required to make a complete installation.
  - 2.1.2 **Authorised Officer** shall mean the person responsible for CPUC sewerage operations reporting to the CEO of CPUC
  - 2.1.3 **Chief Executive Officer** shall mean the person holding the position of General Manager of the CPUC.
  - 2.1.4 **Construction Plans** shall mean Engineering drawings representing the design of a specific

ewe angang.

2.1.6 **CPUC** wewen ewe Chuuk Public Utility Corporation non Chuuk State.

2.1.7 **CPUC Sewer System** wewen ewe nenien atourano kitten nimengaw mi nomw faniten nemenien me amwokut seni CPUC.

2.1.8 **Customer** wewen pwe ewe aramas, ewe offes, sopai a nomw fan nemenien ruomon aramas, ew sopai a nomw fan nemenien fitemon aramas ika ew kumien aramas ra mwicheich fengen, ika pwan faniten ewe muun, ekkewe pwutai non muun, ika ekkoch offesin annuk ekkewe iter mi affat me non taropwen CPUC pun ir mi pwan tongeni eaea ewe nenien atourano kitten nimengaw.

2.1.9 **Customer Sewer Pipe** wewen pun ewe paipen nenien atourano kitten nimengaw mi itiseni nenien ewe chon eaea ngeni ewe nepwopwun nenien atourano kitten nimengaw usun a affat non kinikin 2.1.21.

2.1.11 **Development** wewen ewe fefeitian fonu ika fonu epwe kinikin ika nomw won anapanapan an epwe

2.1.5 **Cost of Sewer Connection** shall mean the sum of the cost of the labor, materials, transportation, equipment, excavation and road repair, if any, and other incidental charges necessary for the complete installation of a sewer connection

2.1.6 **CPUC** shall mean the Chuuk Public Utility Corporation of the State of Chuuk,

2.1.7 **CPUC Sewer System** shall mean the sewer system owned and operated by the CPUC

2.1.8 **Customer** shall mean the person, firm, partnership, corporation or association, regardless of government-connected status, governmental department, or other legal entity whose name appears on the record of CPUC as the party responsible and liable for receiving sewerage service.

2.1.9 **Customer Sewer Pipe** shall mean the sewer pipe extending from the customer property to the sewer manhole as defined in 2.1.21

2.1.10 **Developer** shall mean a person, firm, corporation partnership, association, governmental department, trust or other legal entity, or a combination of any thereof who, or which causes land to be divided into two or more lots, parcels, sites, or other divisions of land for the purpose, whether immediate or future, of sale, lease, rental, transfer of title to or interest in, any or all of such parcels, and shall include redevelopment, and when appropriate to the context shall relate to the process of subdividing or the land or territory subdivided.

2.1.11 **Development** shall mean improved or unimproved land or lands divided or proposed to

- 2.1.12 Development Sewer System** shall mean the sewer system, within any Development, including Sewers, manholes, and all other objects, fittings, or installations required to make a complete installation.
- 2.1.13 Governmental Department** shall mean any department branch, and/or agency of the Chuuk State Government, including an autonomous agency.
- 2.1.14 Or Approved Equal** shall mean a substitute brand or article which may be installed in place of the one name, where such substitute has been approved in writing by the Authorised Officer prior to the actual construction of the Project.
- 2.1.15** In the matter of **Ownership by CPUC and Conveyance of Property and Improvements to CPUC** it shall be understood that the property and improvements are owned by, and that conveyance is made to CPUC.
- 2.1.16 Project** shall mean the structure, undertaking, or improvement to be constructed in whole or in part through the performance of the work covered by these Regulations and all other, Special Provisions.
- 2.1.17 Sewer** shall mean CPUC Sewerage System conveyance pipe to which sewer connections are made
- 2.1.18 Sewer Connection** shall mean the manhole point at which the customers sewer pipe connects into CPUC Sewer

- 3.1 Pwan ew nongonongun an ekkewe aramas repwe eaea sewer, Epwe wor an CPUC me ewe a kefinita pun epwe mesemes won ewe angang pung me nemenem ar repwe tonong won ewe aan, pungun tonong, me ekkoch nenien muun ika fonuen aramas, faniten popun me auchean angangen me kapachetaan ekkewe pisek, me pwan foorsefan, anganga, aeochuono, etti, siwini, me fori awenewenan sokurion won meinisin kinikinin ekkewe nenien inetin konik.
- 3.2 Ese wor niwin epwe kawor ngeni ika kawor seni ese pwan nifinifin aramas, muun ika ekkewe sopai, faniten awesin angang nepekin me orun ewe nenien inetin sewer nupwen ewe angang a fis non nenien ewe chon eaea sewer.
- 3.3 Meinisin pisek mi pacheta won fonuen ewe chon eaea konik pachonong, nge ese pwan aukuk ren paipen sewer, me nenien esipa me suki, usun a kawor seni CPUC faniten kaworen ewe sewer epwe pwan chok pisekin CPUC. - 4.1 Ekkewe annuk, faniten kaworen ewe aninisin nenien atourano kitten nimengaw, usun chok ekkewe annuk a affat ranin an ketiw, iei ra katano.

**PART 3:  
RIGHT OF WAY - RIGHT OF ACCESS**

- 3.1 As a condition for receiving sewer service by customers, CPUC and its authorized agents shall have the free right and authority to enter upon the roads, rights of way, and other public or private property, for the purpose of constructing and installing therewith, and for repairing, operating, maintaining, removing, replacing, and conducting compliance surveys on all or any portion of its distribution system.
- 3.2 No compensation shall be due to or from any customer, public or private, for clearance work around the sewer system which is performed on such customer's premises.
- 3.3 All facilities installed on a customer's premises including, but not limited to pipelines and valves, which are furnished by CPUC in order to render sewer service shall remain the sole property of CPUC. CPUC shall have the right of access to the customer's premises without payment of any charge or rent therefore, at all reasonable hours for any purpose related to the furnishing of sewer service; including, but not limited to, testing, inspection, construction, maintenance, compliance surveying, and repair of facilities. Upon termination of service, and for a reasonable period thereafter, CPUC shall have the right of access to the customer's premises to remove its facilities installed thereon.
- 3.4 The appropriate governmental entities shall provide CPUC with the necessary areas of public property for laying out of the works on public property. Special arrangements, where necessary, shall be made between CPUC and owners of private property for the laying out of the works on private property.

**PART 4:  
EXISTING RULES AND REGULATIONS**

- 4.1 Any regulations, concerning the provision of sewerage services, in existence on the date of adoption of these regulations, are herewith repealed.

- 5.3 Ika pun kapachetaan ewe paipen kitten nimengaw epwe tufich, me pwan epwe wor och sokkun aninis epwe kawor faniten ewe aninis, CPUC ewe pwan esinesin ngeni ewe chon eaea ewe aninis anongonong won nonomwun me momoon epwe foor faniten ewe neeni me mwan an ewe aninisin kaworen nenien kitten nimengaw epwe mumuta.
- 5.4 CPUC ewe opwungano ewe neeni me saisin ewe aninis faniten kapachetaa ngeni ewe nepwopwun. Meinis aninisin kaapchetaa pachonong forutaan ewe nenien kitten nimengaw faniten amokutun me angangen mwirin kapachetaa me ekkoch minafoon kapachetaa ika kattanon kapachetaa epwe kawor seni ewe offesin CPUC inet chok a tufich.

**PART 5:  
GENERAL CONDITIONS**

- 5.1 Any prospective customer whose premises are within service limits established by CPUC, is eligible to apply for sewerage services subject to the following general conditions; and subject to the customer's agreement to abide by these Regulations, and other CPUC Rules.
- 5.2 The premises must be adjacent to an existing sewer main and where ground levels allow gravity discharge from the premise into the sewer main and provided that the capacity of the existing sewer main can accommodate the sewer flows anticipated from the premise/s to be connected.
- 5.3 When extension of sewer lines is necessary, or a substantial investment is necessary to provide service the customer will be informed by CPUC as to the conditions and charges to be made for the particular area and situation in question before sewer service will be approved.
- 5.4 CPUC will determine the location and size of service connections to its system, All service connections including the manhole assembly shall become the property of the CPUC for operation and maintenance after installation and new connections or disconnection may be made thereto by CPUC at any time.
- 5.5 CPUC will exercise reasonable diligence and care to deliver adequate sewerage services but will not be liable for any backflows, overflows or other interruptions or any loss or damage occasioned thereby.
- 5.6 CPUC reserves the right at any and all times to discontinue service with proper notice considering the circumstances for the purpose of making repairs, extensions, alterations, or for other reasons. Repairs or improvements will be performed as rapidly as practicable and, in so far as practicable, at such times as will cause the least inconvenience to the customer.
- 5.7 No unauthorized person shall uncover, make any connections with or opening into, use, alter, or disturb any CPUC Sewerage System without first obtaining a written permit from the Authorised

**PART6:  
APPLICATION FOR SEWERAGE SERVICE**

- 6.1 Each prospective customer upon requesting sewerage service is required to make an application in order to be considered for service.
- 6.2 The customer shall be responsible for the payment of all charges for sewerage service at the designated location. Charges, including construction and connection costs before service will begin when the sewerage service is established and will continue until due notification from the customer or until disconnection by CPUC for failure of the customer to comply with these Regulations.
- 6.3 When an application for sewerage service is made by a customer who was responsible for and failed to pay all bills previously rendered, regardless of location or time incurred, CPUC will refuse to furnish sewerage service to such applicant until his outstanding CPUC bills are paid.
- 6.4 Persons taking possession of a property and using sewerage services without having made application to CPUC for service/s to such property, shall be held liable for the service delivered. If proper application for sewerage service is not made upon notification to do so by CPUC and if accumulated bills for CPUC services are not paid upon presentation, sewerage service shall be subject to discontinuance without further notice.
- 6.5 Any non-governmental entity making a new application for service or any existing customers shall be required to make a guarantee deposit to cover charges for sewerage services.
- 6.6 The amount of the deposit to establish credit required of any customer shall be an amount established by CPUC approximately equal to two months charges for the service or services involved, and as hereinafter indicated.

**PART 7:  
INSTALLATION OF SEWERAGE SERVICE CONNECTIONS**

- 7.1 Installation. When the application for sewerage service has been approved, a sewer connection will be installed by CPUC at the expense of the applicant.
- 7.2 Installation charge. The cost of the sewer connection shall be paid by the applicant before the connection is installed. Installation charges shall be based on the cost of such installation as established by CPUC and shall be as initially set at the charges indicated in paragraph 10 which may be revised time to time.
- 7.3 Customer's sewer pipe. The customer shall install and connect at his expense his sewer pipe to the manhole installed by CPUC. The customer's sewer pipe shall at all times remain the sole property of the customer, who shall be responsible for its maintenance and repair. If the customer's sewer pipe is installed before the sewer connection is set, CPUC will make the connection to it provided, however, it is requested, in writing, by the customer prior to the installation of the sewer connection. Customer sewer piping must be schedule 40 PVC or other material specifically approve in writing by the Authorised Officer.
- 7.4 Sewer Grease Traps In the case of commercial properties and apartment buildings a grease trap must be installed to CPUC standards on the customer's sewer pipe to prevent the ingress of grease and fat into CPUC sewer main. The customer shall at all times be responsible for ensuring that grease traps are properly maintained; failure to do so may result in disconnection of service.
- 7.5 Connection to sewer main. Only employees of CPUC or persons authorized by the Authorised Officer will be allowed to connect or disconnect the sewer connection to or from CPUC sewer main.

CPUC will only remove sewerage – not solid waste or mechanical/oil waste, etc. Ships will pay by load for the sewerage removed by CPUC. Overtime charges must be paid for sewerage removal requested outside of normal working hours.

**PART 8:  
SEWER EXTENSIONS AND EXTENSIONS OF SERVICE**

- 8.1 Extensions of sewer mains to provide sewerage service to applicants of a permanent character shall be constructed, operated, and maintained by CPUC.
- 8.2 CPUC may impose a moratorium on providing new service to customers or increased service to existing customers, if it is determined that such new service would over-burden the existing sewer network capacity. If a customer violates the conditions of the moratorium by increasing sewerage discharge, the customer may, at the discretion of CPUC, be subject to disconnection.
- 8.3 Any extension of existing sewerage service is contingent upon the availability of funds; which are identified for expansion purposes. CPUC has discretion to determine the area(s) to which sewerage service shall be extended. Sewerage service shall be extended to areas, to which CPUC has determined to extend service, in the order in which applications are approved for sewer connection.
- 8.4 Any extension of sewerage service to an area other than one to which CPUC has determined to extend service shall be primarily at the customer's expense.
- 8.5 If necessary, and subject to Board approval, the cost of extension of sewerage service may be amortized over a period up to five (5) years, in this case the cost of extension will include financing charges at commercial market rates. In such a case, the customer's water bill shall include both an amount for sewerage service at the applicable rate and the amortization payment for the extension of sewerage service.

**PART 9:**  
**DISCONTINUATION OF SEWERAGE SERVICE**

- 9.1 Sewerage service may be discontinued for reasons as follows:
- 9.1.1 Non-payment of bills, Sewerage service may be discontinued for the non-payment of a bill within 15 days after the delivery to the customer. If a customer is receiving service at more than one location, service at any or all locations may be discontinued if works for and service at any one or more locations are not paid within the period specified herein.
- 9.1.2 Non-compliance with CPUC's Regulations. If the customer fails to comply with any of these Regulations CPUC will have the right to discontinue the service.
- 9.1.3 Customer about to vacate premises. Each customer about to vacate any premises supplied with sewerage services by CPUC shall give 10 working days notice of his intention to vacate prior thereto specifying the date service is desired to be discontinued. Before buildings are demolished, CPUC should be notified so the sewer connection can be closed.
- 9.1.4 Service detrimental to others. CPUC will refuse to furnish sewerage services to any premises where the demands of the customer will result in inadequate service to the rest of the existing system.
- 9.1.5 CPUC shall have the right to refuse service or discontinue service if the acts of the consumer or the conditions upon his premises are such as to indicate intention to defraud CPUC.
- 9.1.6 Restoration of service. If sewerage service is terminated because of failure to pay a bill, for violation of any of the regulations of CPUC, or for other reasons, all outstanding accounts against the customer must be paid before sewerage service will be restored. In addition, the reconnection charge, must be paid before the

**PART 10:**

**SCHEDULE OF RATES AND CHARGES**

10.1 CPUC may develop and implement rate schedules segregated into customer categories. Implementation of such rate schedules shall be in accordance with Chuuk State Law No. 3-97-05 as amended.

10.2 Current rate schedules are in accordance with Chuuk State Law No. 3-97-05 as amended and approved by the CPUC Board of Directors copy of which is to be posted at all times at CPUC main office and notice boards and included as Annex 1 to these Regulations and updated thereto whenever issued.

10.3 Rate schedules will include information for the following types of charges:

Inspection Fees  
Connection Fees;  
Reconnection Fees;  
Penalties;  
Sewerage Tariff Rates (including standing charges and other charges where applicable);

Sewage waste removal from properties, septic tanks, ships, etc.

10.4 CPUC's rate schedules shall be interpreted and applied by the CPUC for each customer's service requirement in accordance with the terms and conditions of such rate schedules and the size and characteristic of such service requirements, as these are determined from time to time.

10.5 A customer who is adversely affected by the application of any rate or charge for sewerage service may challenge the rate or charge, and if the customer and CPUC do not reach agreement, the latter shall be adjudicated in accordance with the State Administrative Procedures Act.

10.6 If a customer elects to change to another appropriate and applicable rate schedule, the

- 10.6.3.1 The change is not made more often than once in twelve (12) months; and

- 10.7 Type of customers are classified as:
- 10.7.1 Residential customers are those who utilize sewerage services in a single family house or an apartment. In the case of an apartment house which has one sewer connection for the entire building, the building is considered a residential building and qualifies for the residential rate.
- 10.7.2 Private schools and religious institutions shall be classified as residential.
- 10.7.3 If a building has separately sewerred apartments, and part of the building is commercial which is separately sewerred, the apartments shall be classified residential.
- 10.7.4 An apartment building with one sewer connection serving the entire building, that has a commercial business located in the building, is considered commercial for the entire building.

**PART 11:  
CPUC EQUIPMENT ON CUSTOMER'S PREMISES**

- 11.1 All equipment belonging to CPUC and installed upon the customer's premises for measurement, test, check or any other purpose, shall continue to be the property of CPUC, and may be repaired, replaced or removed by CPUC at any time by notifying the customers. The customer shall exercise reasonable care to prevent damage to meters and other equipment of CPUC upon said premises and shall in no way interfere with the operation of same.
- 11.2 Any damage to sewer mains, manholes, sewer connections or other property of CPUC shall be paid for by the person or organization responsible for the damage.
- 11.3 The customer shall be liable for any damage to equipment or property of CPUC caused by the customer or his tenants, agents, employees, contractors, licensees or permittees, on the customer's premises and CPUC shall be promptly reimbursed by the customer for any such damage upon presentation of a bill therefore. In the event settlement for such damage is not promptly made, CPUC reserves the right to discontinue sewerage services to such premises.
- 11.4 No obstruction nor guard dogs or any other hindrances shall be placed on or around any manhole so as to render it inaccessible.
- 11.5 Any officer or employee of CPUC shall have the right of ingress and egress to the consumer's premises at all reasonable hours for any purpose reasonably connected with the furnishing of sewerage service to said premises and the exercise of any and all rights secured to it by law. In case any such officer or employee is refused admittance to any premises, or being admitted shall be hindered or prevented from making such inspection, CPUC may cause the sewerage services to be disconnected from said premises after giving 24 hours notice to the owner or occupant of said premises of its intention to do so.

**PART 12:  
RESPONSIBILITY FOR CUSTOMER'S EQUIPMENT**

- 12.1 The customer shall at his own risk and expense furnish, install and keep in good and safe condition all equipment that may be required for discharging sewerage; and CPUC will not be responsible for any loss or damage caused by the improper installation of such equipment, or the negligence, want of proper care or wrongful act of the customer or any of his tenants, agents, employees, contractors, licensees or permittees in installing, maintaining, using, operating or interfering with any such equipment
- 12.2 Sewerage service may be discontinued to any customer whose sewerage system includes plumbing fixtures in any form, or any use, which in the opinion of CPUC may endanger CPUC's sewerage service. Any such discontinuation of service shall continue until objectionable installations have been corrected and CPUC has been assured that the objectionable uses and practices will not be resumed.
- 12.3 Sewer Grease Traps The customer shall at all times be responsible for ensuring that grease traps are properly maintained; failure to do so may result in disconnection of service.

**PART 13:  
ELECTRICAL GROUNDING**

- 13.1 Protective grounding of alternating current secondary distribution circuits made to the sewer system shall be subject to written approval by CPUC.
- 13.2 No grounding of direct current system to any portion of the sewer system shall be permitted.
- 13.3 CPUC will not be responsible for the maintaining of a continuous metallic sewer piping system and reserves the right, without liability to public utility electric companies, electric customers, or any other agency or individual to create a physical break in its sewer connections and mains, or to incorporate

**PART 14:  
USE OF AND DAMAGE TO MANHOLES**

- 14.1 The primary purpose of the provision of manholes in CPUC sewer systems is to assist the effective operation and maintenance of the sewer system.
- 14.2 Use of Manholes. Any use of a manhole or tampering therewith or the discharge of waste of any description therein is prohibited, except upon prior application to and written permit by CPUC. The use of any manhole under a permit shall be subject to the direction and approval of the CPUC, including the payment of appropriate charges.
- 14.3 Application for Permit. Application for a permit for the use of a manhole for purposes other than fire protection shall be made in writing to CPUC and when required, shall be accompanied by payment of the applicable manhole usage charges. It shall be non-transferable and shall be shown by the permit, its agents or employees upon demand. CPUC reserves the right to reject any application, to refuse to issue any permit and to revoke any permit at any time. No permit will be issued unless the permittee agrees to notify CPUC as soon as the use of the manhole is finished. In the event that a permit shall be revoked, the use of the manhole thereunder shall cease immediately and all connections thereto shall be properly removed forthwith. CPUC will inspect each manhole which has been used under a permit, and all costs of repairs which the CPUC may adjudge to be due to such use and the cost of inspection shall be paid for by the permittee. All waste water discharged to a manhole under permit shall be metered or estimated by CPUC and shall be paid for by the permittee at the prevailing rate.

CPUC will not be held responsible for any damage to property or injury to persons arising from the use of any manhole for any cause whatsoever. Any damage to manholes shall be paid for by the person or organization responsible for the damage.

**PART 15:  
SEWERAGE SYSTEM DEVELOPMENT REGULATIONS**

15.1 Availability of Sewerage Treatment Capability and Approval of Development Map

15.1.1 Extensions from and connections to the public sewer system will be approved by CPUC where elevations permit; provided that CPUC has sufficient capacity installed in the sewer collection system and at the receiving sewerage treatment plant;

15.1.2 In areas where there is no CPUC sewerage system available, or where large quantities of sewage is to be disposed of; or a large investment is necessary to provide service, the developer will be informed as to the conditions under which the development may be approved.

15.1.3 After a governmental department submits the development map to CPUC along with the backup information, CPUC will inform the department in writing of its approval, requirements for approval, or its disapproval of extension or connection to CPUC sewerage system map based on sewerage utility service capabilities. No statement, prior to CPUC approval, should be construed as a guarantee availability of sewerage service at a certain location where development is proposed to take place. CPUC approval will only be given if all Government Planning Rules and Regulations, including Environmental Impact Assessment if applicable, outside those of CPUC itself have been complied with and evidence thereof furnished by the relevant department.

15.2 Extension to Development

15.2.1 General Requirement. The developer shall install and pay for the development sewerage extension required from CPUC sewerage systems to the development. All such extensions shall be designated and located in accordance with CPUC standards.

Whenever CPUC finds it is necessary that the sewer mains need be of a greater capacity than to provide adequate service for such development, in order to supply service to property not in the development, it shall require the developer to install mains of such greater capacity.
- 15.3 Installations Within Development
- 15.3.1 General Requirement. The developer shall install in accordance with these Regulations and the Standards of CPUC and pay for the development sewerage system required within a development.
- 15.3.2 Increase in size of sewer mains within development for benefit of other areas. Whenever, in order to provide for existing or future services beyond the boundaries of a development, CPUC finds that sewers to be installed within the development should be of greater capacity than would be required to provide adequate service within such development, CPUC will require the developer to make installations of such greater capacity.
- 15.3.3 If and when reimbursement to developer, who is required to install a larger size sewer for the reason set forth in the proceeding paragraph, CPUC will reimburse the developer, as soon as practicable after acceptance by CPUC of the completed work, the additional cost of the installation over and above the cost of the mains that would have been required; provided, however, that in no case will reimbursement be made of any portion of the cost of an 8-inch sewer in other areas; provided further that reimbursement will not be made to the developer where such larger main or mains will serve only areas under the same ownership as the development under consideration.
- 15.3.4 After the installation has been completed and accepted by CPUC, the developer shall furnish

**15.4 Preparation and Approval of Plans, Elevation Agreement, Delay in Construction**

**15.4.1 Preparation of Plans.** All construction plans shall be prepared by a registered engineer to the extent of his professional qualifications and approved by CPUC Authorised Officer. Tentative maps and final maps of developments to be reviewed by the CPUC shall fully conform to the definitions and requirements of the development Rules and Regulations of the Chuuk State Government.

**15.4.2 Approval of Plans.** No construction of a development sewerage system, or any portions thereof shall be undertaken prior to approval of the final construction plans by CPUC. After said approval, the developer shall transmit four sets of all final construction plans to CPUC. In areas where there is no CPUC sewerage service available to serve the development, plans specifications for the development of sewerage treatment facilities including tunnels, shafts, pumps, buildings, mains and other appurtenant structures and devices, shall be approved by CPUC in their entirety prior to construction.

**15.5 Materials and Construction Standards, Installation of Sewerage Service**

**15.5.1 Materials and Construction Standards.** All materials, design and construction procedures, and workmanship, with respect to any development sewerage system, or any portion thereof shall be in accordance with the requirements and Standards of CPUC.

**15.5.2 Installation of Sewerage Service.** No sewerage service will be approved, excepting a service for development construction purposes, until the development sewerage system has been completed and accepted by CPUC and all the improvements required by the Development Rules and Regulations have been completed,

15.6.1 As a condition precedent to connecting the project sewerage system to the public sewerage system, the developer shall convey the sewerage system to CPUC and said system thereafter will be maintained and operated as a part of the public sewerage system provided, however, that CPUC may refuse to operate and maintain facilities installed without CPUC's prior approval. Prior to commencement of sewerage services and as a prerequisite to such service, the developer shall deliver to CPUC perpetual easements for all portions of the sewerage system installed other than publicly owned property. The developer shall also convey, without cost to CPUC, fee simple title to all sites on which are located tanks, treatment facilities, and pumps constructed by the developer and connected to the public sewerage system together with easements for access, sewer pipeline and other necessary utility purpose.

**PART 16:  
INDUSTRIAL WASTE WATER DISCHARGE TO CPUC  
SEWERAGE SYSTEM**

16.1 All industrial waste water discharges to CPCU sewerage system must be pre-treated to the relevant discharge standard; CPUC may test industrial discharges before and after pre-treatment to ascertain the effectiveness of pre-treatment – all such testing will be the responsibility of the customer.

16.2 Failure to meet the discharge standard will result in disconnection of service and application of the appropriate penalties as specified in the schedule of charges Annex 1.
